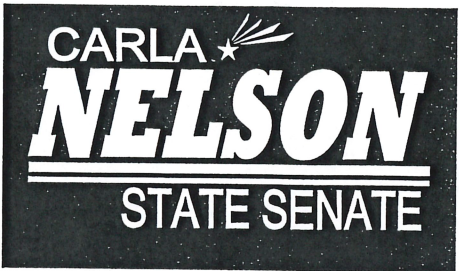
The Campaign wants to formally apologize to you and the Board. We do not take this lightly and we have put procedures in place to make sure that this does not happen again.

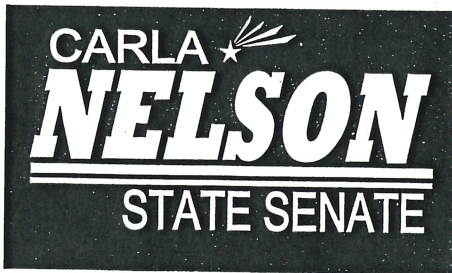
